As an FYI, the USPTO is releasing procurement records related to the ID.me contract award for Trademark applicant identity verification in response to a FOIA request (records to go out today or tomorrow). The contract was sole-sourced to V3Gate, which partners with ID.me, after it was the only party to submit a bid. Trademarks had delayed implementation of mandatory identity verification back in March, but starting August 6, 2022, verification will be required for USPTO.gov account holders to file trademark forms, and ID.me will be one of the verification methods.

- Past Week (b)(5) Delib Proc Priv
 - USPTO Director Gave Keynote During Fireside Chat at License on Transfer Network's (LOT Network) Annual Member Meeting: On September 29, Kathi Vidal, Under Secretary of Commerce for Intellectual Property and Director of the United States Patent and Trademark Office (USPTO), gave a keynote during a fireside chat at the annual member meeting of the LOT Network, a nonprofit community of companies that supports open innovation and responsible stewardship of technology. Caren Ulrich Stacy, the USPTO's Lead Advisor on Diversity, Equity, Inclusion, and Accessibility (DEIA), joined Director Vidal for the fireside chat. This year's meeting focused on diversity, equity, and inclusion initiatives companies and organizations around the globe are discussing and implementing.

 - USPTO Offers Webinar for Native American, Alaska Native, and Native Hawaiian Visual Artists: On October 6, the USPTO, in cooperation with the Department of the Interior's Indian Arts and Crafts Board and the nonprofit Indian Dispute Resolution Services Inc., will conduct a webinar for Native American, Alaska Native, and Native Hawaiian visual artists and craftspeople on ways to enhance marketing plans for seasonal/holiday sales. This event is part of an ongoing series that supports the USPTO's mission to broaden participation in the innovation ecosystem.

SIGNIFICANT EXECUTIVE ORDER (EO) IMPLEMENTATION & ADDITIONAL AGENCY ACTIVITY

- Past Week (b)(5) Delib Proc Priv
 - USPTO Seeks Public Input on Initiatives to Improve the Robustness and Reliability of Patent Rights: On October 4, the USPTO published a request for comments on initiatives directed at bolstering the robustness and reliability of patents.

Through this notice, the USPTO is further emphasizing that clear, enforceable patents are essential to economic growth, global competitiveness, and investment in innovation, including in key technology areas. The notice is part of the USPTO's ongoing efforts to strengthen our intellectual property system to promote and protect innovation, while actively preventing activity that improperly or unnecessarily delays the ability of every American to benefit from that innovation. The USPTO is accepting comments through January 3, 2023.

- O USPTO Extended the Fast-Track Appeals Pilot Program: On September 29, the USPTO's Patent Trial and Appeal Board (PTAB) announced the second extension of the Fast-Track Appeals Pilot Program. Under this program, appellants with a docketed ex parte appeal may file a petition to expedite review of the appeal by the PTAB. The extension continues the program through July 2, 2024. Currently, the average appeal pendency is about 12 months, down from 15 months in 2020, and 30 months in 2015. Using the appeal process may be more expeditious for inventors and may speed the ultimate issuance of patents as opposed to request for continued examination practice.
- O USPTO's PTAB Extended the Motion to Amend (MTA) Pilot Program: On September 30, the USPTO's PTAB announced an extension of the MTA Pilot Program until September 16, 2024, or earlier if replaced by a permanent program after notice-and-comment rulemaking. The program provides a patent owner who files an MTA with options to request preliminary guidance from the PTAB on the MTA and to file a revised MTA. The MTA Pilot Program also provides timelines for briefing to accommodate these options. The MTA Pilot Program is intended to provide a more efficient and effective opportunity for patent owners to preserve their patent rights by providing them feedback on their amended claims.
- USPTO Director Vidal Issued a Precedential Director Review Decision Regarding Abuse of the Inter Partes Review (IPR) Process: On October 4, Director Vidal issued a precedential Director review decision regarding abuse of the IPR process in OpenSky Industries, LLC v. VLSI Technology LLC, IPR2021-01064, Paper 102. The Director review decision

held that the petitioner, OpenSky, abused the IPR process by (1) filing an IPR in an attempt to extract payment from both the patent owner, VLSI, and the joined petitioner, Intel; and (2) proposing to undermine the proceeding to extract the payment from VLSI. Director Vidal sanctioned OpenSky by precluding OpenSky from actively participating in the IPR and temporarily elevating Intel to the lead petitioner. Director Vidal further ordered OpenSky to show cause why it should not be ordered to pay compensatory damages to VLSI. Finally, in an effort to balance the competing interests at issue in this case and to determine whether to maintain or dismiss the underlying proceeding, Director Vidal remanded to the PTAB to determine whether the petition, based only on the record before the PTAB prior to institution, presents a compelling, meritorious challenge.

USPTO Deputy Director Discussed USPTO Initiatives at Roundtable and Fireside Chats in Houston and Galveston: On September 29-30, Derrick Brent, Deputy Under Secretary of Commerce for Intellectual Property and Deputy Director of the USPTO, took part in a series of events in Houston and Galveston on behalf of the USPTO. At the Baylor College of Medicine, he participated in a roundtable in which he discussed a range of topics, including expanding the innovation ecosystem and ensuring robust and reliable patents. Deputy Director Brent also took part in a fireside chat with University of Houston-Clear Lake students, in which he discussed career opportunities in the field of intellectual property as well as the patenting process and resources available for inventors. In addition, Deputy Director Brent participated in a fireside chat at the Houston Intellectual Property Law Association's 38th Annual Fall Institute on Intellectual Property Law. At this event, he spoke on topics such as pro bono programs and the USPTO's DEIA initiatives.



- Director Review Granted in Inter Partes Reviews at USPTO's Patent Trial and Appeal Board: On June 7, Kathi Vidal, Under Secretary of Commerce for Intellectual Property and Director of the USPTO, issued orders granting sua sponte Director review in OpenSky v. VLSI and Patent Quality Assurance v. VLSI, two inter partes reviews (IPRs) instituted at the USPTO's Patent Trial and Appeal Board (PTAB). The recent orders notify the parties of the Director's intention to review the PTAB decisions instituting these proceedings. The orders do not include a decision on the merits but indicate that a scheduling order for briefing, including amicus briefing, will be forthcoming. During the review itself, Director Vidal will consider allegations of abuse of process by petitioners pursing IPRs after a district court found infringement and awarded large damages in relation to two patents at issue. The grant of Director review in these cases reflects Director Vidal's commitment to ensuring that IPRs at the PTAB serve the public good, are not misused, and work for their intended purposes.
- USPTO Unveils New Patent Quality Metrics Webpage: On June 2, the USPTO published a new patent quality metrics webpage, which shares with the public the metrics the Agency uses to gauge patent examination quality. The webpage also reveals how the USPTO assesses the quality of its processes and measures stakeholders' perceptions. The USPTO will use the data on the webpage, as well as internal, Patent Public Advisory Committee, and direct stakeholder input, to guide improvements. In doing so, the USPTO is continuing to increase the robustness and reliability of U.S. patents that incentivize and protect innovation and investments.

o **USPTO Forms Al/ET Partnership:** On June 7, the USPTO announced an initiative to form a partnership (Al/ET Partnership) with the artificial intelligence (Al) and emerging technologies (ET) communities, including, for example, academia, independent inventors, small businesses, industry, nonprofits, and civil society. The Al/ET Partnership will provide an opportunity to bring stakeholders together through a series of engagements to share ideas, feedback, experiences, and insights on the intersection of IP, Al, and other ET (e.g., quantum computing, synthetic biology, blockchain, precision medicine, and virtual reality). Through these efforts, the USPTO seeks to promote the importance of IP rights and ensure that proper incentives are in place to foster innovation in these critical areas.

 - USPTO Seeks Public Input on Initiatives to Improve the Robustness and Reliability of Patent Rights: On October 4, the USPTO published a request for comments on initiatives directed at bolstering the robustness and reliability of patents.

Through this notice, the USPTO is further emphasizing that clear, enforceable patents are essential to economic growth, global competitiveness, and investment in innovation, including in key technology areas. The notice is part of the USPTO's ongoing efforts to strengthen our intellectual property system to promote and protect innovation, while actively preventing activity that improperly or unnecessarily delays the ability of every American to benefit from that innovation. The USPTO is accepting comments through January 3, 2023.

- USPTO Extended the Fast-Track Appeals Pilot Program: On September 29, the USPTO's Patent Trial and Appeal Board (PTAB) announced the second extension of the Fast-Track Appeals Pilot Program. Under this program, appellants with a docketed ex parte appeal may file a petition to expedite review of the appeal by the PTAB. The extension continues the program through July 2, 2024. Currently, the average appeal pendency is about 12 months, down from 15 months in 2020, and 30 months in 2015. Using the appeal process may be more expeditious for inventors and may speed the ultimate issuance of patents as opposed to request for continued examination practice.
- O USPTO's PTAB Extended the Motion to Amend (MTA) Pilot Program: On September 30, the USPTO's PTAB announced an extension of the MTA Pilot Program until September 16, 2024, or earlier if replaced by a permanent program after notice-and-comment rulemaking. The program provides a patent owner who files an MTA with options to request preliminary guidance from the PTAB on the MTA and to file a revised MTA. The MTA Pilot Program also provides timelines for briefing to accommodate these options. The MTA Pilot Program is intended to provide a more efficient and effective opportunity for patent owners to preserve their patent rights by providing them feedback on their amended claims.
- USPTO Director Vidal Issued a Precedential Director Review Decision Regarding Abuse of the Inter Partes Review (IPR) Process: On October 4, Director Vidal issued a precedential Director review decision regarding abuse of the IPR process in OpenSky Industries, LLC v. VLSI Technology LLC, IPR2021-01064, Paper 102. The Director review decision

held that the petitioner, OpenSky, abused the IPR process by (1) filing an IPR in an attempt to extract payment from both the patent owner, VLSI, and the joined petitioner, Intel; and (2) proposing to undermine the proceeding to extract the payment from VLSI. Director Vidal sanctioned OpenSky by precluding OpenSky from actively participating in the IPR and temporarily elevating Intel to the lead petitioner. Director Vidal further ordered OpenSky to show cause why it should not be ordered to pay compensatory damages to VLSI. Finally, in an effort to balance the competing interests at issue in this case and to determine whether to maintain or dismiss the underlying proceeding, Director Vidal remanded to the PTAB to determine whether the petition, based only on the record before the PTAB prior to institution, presents a compelling, meritorious challenge.

 USPTO Deputy Director Discussed USPTO Initiatives at Roundtable and Fireside Chats in Houston and Galveston: On September 29-30, Derrick Brent, Deputy Under Secretary of Commerce for Intellectual Property and Deputy Director of the USPTO, took part in a series of events in Houston and Galveston on behalf of the USPTO. At the Baylor College of Medicine, he participated in a roundtable in which he discussed a range of topics, including expanding the innovation ecosystem and ensuring robust and reliable patents. Deputy Director Brent also took part in a fireside chat with University of Houston-Clear Lake students, in which he discussed career opportunities in the field of intellectual property as well as the patenting process and resources available for inventors. In addition, Deputy Director Brent participated in a fireside chat at the Houston Intellectual Property Law Association's 38th Annual Fall Institute on Intellectual Property Law. At this event, he spoke on topics such as pro bono programs and the USPTO's DEIA initiatives.

What is PTAB?

The Patent Trial and Appeal Board (PTAB) was created by Congress in 2012 to provide a quicker way to challenge potentially bad patents without having to go to district court.

The PTAB gives USPTO a way to help police its own 'bad patents.'

- The tech and financial services industries in particular were being plagued by lawsuits alleging that they infringed broadly written patents. Rather than spend millions challenging the patent in court, they often had to just settle the cases even if they believed the patent at issue was not applicable.
- Some patent holders including small inventors, some research universities, and others have raised concerns that PTAB is too quick to invalidate a patent and would like to reform the standard that a petition must meet before PTAB takes up a case.

What is *Fintiv*?

Fintiv is a PTAB case made precedential by the last Administration that established a multi-prong test for when PTAB would take up a case.

- The last Director put a process in place ("Fintiv") to permit discretionary denial of a PTAB review even when the patents would have otherwise warranted review if the case met a test with multiple factors, but heavily weighted towards whether district court proceedings and PTAB proceedings could potentially occur at the same time.
- While Senator Coons and Tillis support the Fintiv test, Senator Leahy, current House IP subcommittee Chairman Johnson and incoming Chairman Issa and the public expressed concerns that (1) the USPTO was relying on trial dates that did not stick; (2) the USPTO was potentially denying review of weak patents.
- Unrelated to any specific case, such as OpenSky, Director Vidal, upon confirmation, updated how Fintiv was to be applied, so that if a patent was sufficiently weak and the case against it was strong, the PTAB would not discretionarily deny a review of such a patent. This update to Fintiv was intended to preserve the balance and discretion that Fintiv created while allowing the USPTO to still remove truly bad patents from the ecosystem.

How did the *OpenSky* case start?

The OpenSky case stems from a U.S. District Court Case in which VLSI sued Intel for infringing two VLSI patents.

Note: OpenSky was not a party to this District Court case.

In response to VLSI's lawsuit, Intel challenged the validity of VLSI's patents and requested PTAB's review of these patents.

Intel's PTAB review was denied by the last Administration in one of the first applications of the *Fintiv* precedent because of the advanced state of district court litigation and the overlapping issues between the PTAB petitions and the district court complaints.

Note: (b)(5) Delib Proc Priv

In March 2021, the district court jury found Intel infringed both VLSI patents and awarded damages of \$2.2 billion.

Note: the validity of VLSI's patents was not addressed by the jury.

But how is OpenSky involved and what did USPTO decide?

After this district court trial, an unrelated third-party –OpenSky-- then filed at the PTAB a <u>nearly identical petition to Intel's</u> challenging VLSI's patents.

 Note: <u>per the law, Intel was able to join OpenSky's PTAB case</u> because by statute the post-trial time bar does not apply to a secondary party, such as Intel, merely joining a PTAB proceeding

The PTAB instituted the review because the underlying patents in question were sufficiently weak and the case against them were strong.

Director Vidal reviewed OpenSky's case and (1) confirmed that the PTAB should review the VLSI patents and (2) prevented OpenSky from participating in the PTAB review because it was abusing the PTAB system to extract payments from other parties in the case.
